This regulation shall not apply to Masons who are Master Masons in Good Standing in a Jurisdiction recognized by Idaho but not a member of an Idaho Constituent Lodge, or to Masons who have become a member of an Idaho Lodge by affiliation from another Grand Lodge Jurisdiction.
