Note: Grand Lodge, Ancient Free & Accepted Masons of Idaho, Regulation No. 9, Code and Digest as amended 2002

"No Mason, raised in Idaho after September 18, 1952, shall apply for or receive any Scottish Rite or Royal Arch Chapter Degree until he shall have passed a satisfactory examination in the lecture of the Master Mason Degree, in open Lodge or before a committee. This regulation shall not apply to Masons who are Master Masons in Good Standing in a Jurisdiction recognized by Idaho but not a member of an Idaho Constituent Lodge, or to Masons who have become a member of an Idaho Lodge by affiliation from another Grand Lodge Jurisdiction. This Regulation shall be printed on all forms on "Petition for Degrees."
